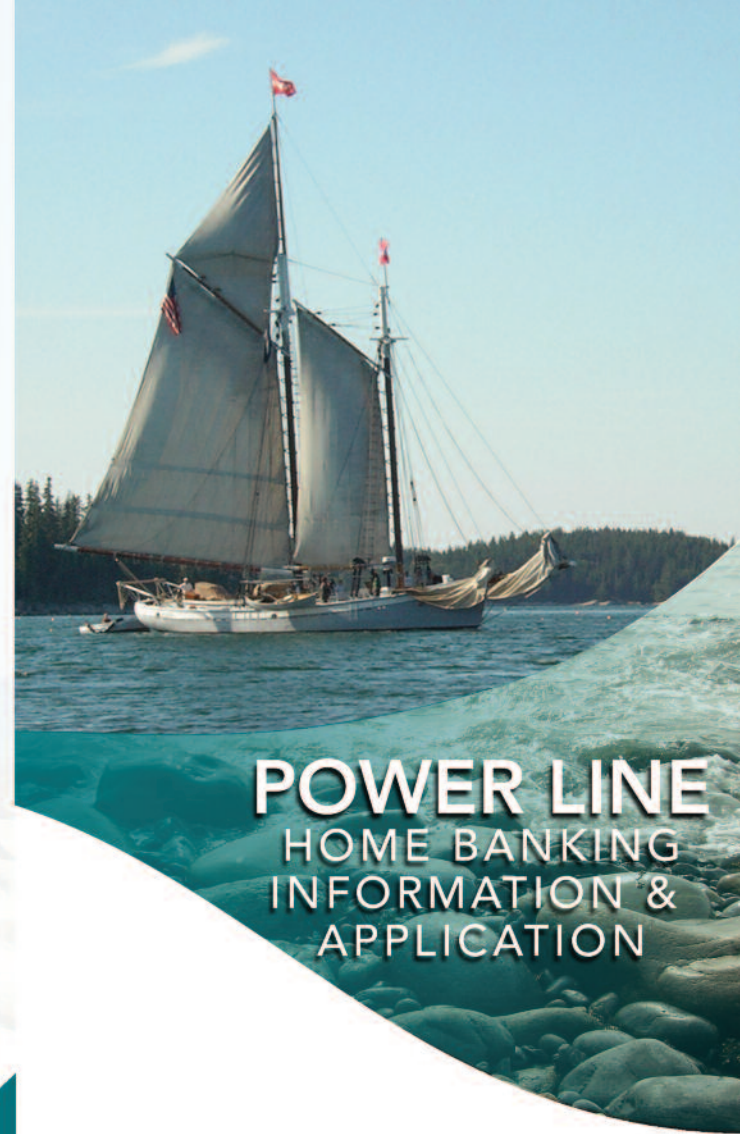

If you are a member of Seaboard Federal Credit Union, **Power Line** is FREE! And it's easy.

With **Power Line**, you can see your account on screen with our online, real-time information! You access it via the Internet so there's no need to install or learn special software. And, you just point and click to begin your account transactions.

- Make loan payments
- Order savings bonds
- Place stop payments on checks (\$25.00 fee)
- Request a check

- Password reset feature (never get locked out again)
