HELOCs and Home Equity Loans

If your home has gained value, your home equity position has likely improved, too. (Your equity is what's left when you subtract what you owe on your home from its fair market value.) That could make a home equity loan or line of credit a good way to borrow. You can use the funds for home repairs, education expenses, or even financial emergencies.



- Choose a loan if you need a lump sum. An equity loan's rate and payment amount are usually fixed, giving you more peace of mind.
- Choose a line of credit if you need financial flexibility. Equity lines of credit typically have variable rates and more payment options.
- Save money compared to other kinds of credit. You pay a relatively low interest rate because your loan or line is secured by your home.

Enjoy tax advantages. Interest is usually deductible if you itemize.*
